Examination of Elmbridge Borough Council's Draft Elmbridge Local Plan 2037 - Notice of Independent Examination Hearing

The Draft Elmbridge Local Plan 2037 was submitted to the Secretary of State for its independent Examination on 10 August 2023. The Secretary of State has appointed Christa Masters MA (Hons) FRTPI to carry out an independent Examination of the Plan and subsequently issue a report with conclusions. As part of the independent Examination, the Inspector will hold a number of public hearing sessions.

Stage 1 Hearing Sessions

Stage 1 of the Examination in Public (EiP) hearing sessions were announced on Wednesday 20 December 2023 with the corresponding <u>Public Notice</u> published the same day.

The Stage 1 hearings will be held during the week beginning 26 February 2024. The hearing sessions will commence on Tuesday 27 February, at 10:00 am, with Wednesday 28 February in reserve (also starting at 10:00 am).

The session will cover Matter 1: the Duty to Cooperate, Legal and Procedural Compliance. The Inspector's MIQs and guidance note for Stage 1 are available to view in the <u>Hearing Sessions</u> area of the Council's Local Plan Examination website.

Stage 2 Hearing Sessions

Stage 2 of the EiP hearing sessions will cover the spatial strategy and the distribution of growth over the Plan period, including the approach to the Green Belt and site allocations. The Inspector's MIQs and guidance note for Stage 2 are available to view in the <u>Hearing Sessions</u> area of the Council's Local Plan Examination website.

The sessions will be structed by the following matters:

- Matter 3: the vision, spatial strategy and the distribution of growth over the Plan period

- Matter 6: affordable housing

- Matter 7: other housing matters
- Matter 8: meeting employment needs
- Matter 9: site allocations
