Introduction

The 'Community Infrastructure Levy Regulations 2010 (as amended)' amendment PART 10A requirement 121A, which came into force in September 2019, sets out the new reporting requirements for Community Infrastructure Levy (CIL) and planning obligations in relation to the previous financial year ("the reported year"). The Annual Infrastructure Funding Statement (AIFS) must be published by 31st December.

As per requirement 121A, the AIFS should include:

- A statement of the infrastructure projects or types of infrastructure which the charging authority will be or may be or partly funded by CIL.
- A report about CIL, in relation to the previous financial year which includes the matters specified in paragraph 1 of Schedule 2
- A report about planning obligations, in relation to the reported year, which includes the matters specified in paragraph 3 of Schedule 2 and may include the matters specified in paragraph 4 of that Schedule.

The following statement sets out these details for Elmbridge Borough Council for the reporting year 1 April 2023 – 31 March 2024.

The council has been collecting CIL since the Charging Schedule came into effect in 2013. The council is using CIL in conjunction with infrastructure providers to deliver improvements borough-wide and at a local level where the development takes places. All CIL funding awards are done through a competitive bid and review process.

An initial 5% of CIL funds generated in the borough each year is retained by the council for administration purposes. If, during the reported year, the processes are costing the Council more to administer, the cost over the 5% would be paid from the Council's General Fund and not paid from the CIL funds.

In addition, 15% of the funds collected is used to support the local area within which the development generating the CIL is located. The local CIL funds are allocated through the Local Spending Boards (consisting of Ward Councillors for the area), except in the case of Claygate where the local CIL funds are passed to the Parish Council to allocate as per the regulations.

The remaining 80% of the CIL funds are allocated towards strategic borough-wide infrastructure and are assigned as follow:

- 73% of CIL is allocated through the Strategic Priority Programme (SPP) for strategic infrastructure that the council has agreed
 to support and that are required to bring forward development and enable future growth.
- 15% of CIL is ringfenced for Active Travel and Public Realm projects to be delivered is collaboration with Surrey County Council (SCC).
- 12% of CIL is ringfenced for maintenance purposes as agreed and approved through the capital application programme, by Cabinet and Council.

Oxshott Community Hub: The new home of Oxshott Scouts and Guides

Set in an ancient woodland, the brand-new community hub opened in 2024. Funded primarily by Your Fund Surrey from Surrey County Council and CIL Funding from Elmbridge Borough Council as well as a numerous local Girlguiding and Scouting fundraising.





The new facilities host a variety of community groups and deliver a diverse programme that provides young people in Oxshott with a safe space to make friends, learn new skills and have fun.


The new Oxshott Community Centre replaces a 1968 timber framed building which was leaking, had no insulation and an inefficient heating system. The new building has low energy lighting, adequate insulation, and double glazing. The centre is also fully accessible and includes disabled toilets, a baby changing room, a modern fitted kitchen and two large halls and one also a meeting room.





Claygate Community Pool

The project saw the complete refurbishment of the existing pool to create a heated, indoor, community swimming pool open to all. The pool is open every day with lifeguard, and it offers something for everyone from adult lane swimming, family fun sessions, swimming lesson and birthday pool party.
